Painted and Stained Finish Characteristics Acceptance

Canyon Creek Cabinet Company wants you to be satisfied with the choices you made with your cabinetry. The cabinet samples displayed in our showroom give you a representation of the stain/paint you will receive, but it must be noted that this is simply a representation and the final end product can vary.

PAINT: Please note that paint cracking in the joints of the cabinets is normal. Joints on face frames, doors, the attachment points, and joints of trims and mouldings may become more noticeable due to the natural expansion and contraction of the material. These joint paint cracks are a naturally occurring phenomenon and are not considered defects.

As painted cabinets age, the finish may mellow or discolor slightly. The degree of change to the original finish color is affected by your cabinets' exposure to natural and artificial light. This is a normal characteristic of painted cabinetry and not considered a quality defect. See Painted Cabinets: What to Expect* for more information.

GLAZING, DISTRESSING, & SPECIALTY FINISH

ENHANCEMENTS: All of our finish enhancements are applied by hand and are designed to be random and unique. They will exhibit variations between the original sample and finished product as well as between other doors and drawer faces that are part of the same order. This is natural with hand-application and is not considered a factory defect.

UNFINISHED & SEALER ONLY: Unfinished product orders, where the cabinets will be stained by another party, are finish-ready for stain. All Sealer Only orders are intended for products that will be painted by another party and

must be sanded prior to applying paint to ensure mechanical adhesion.

The customer assumes responsibility for all subsequent issues relating to the selection of "Unfinished" or "Sealer Only" product. We make no representation of warranty, either written or implied, for these items.

ENVIRONMENTAL FACTORS: Due to wood's organic composition, it can be reactive to changes in temperature and/or humidity. Variations in these conditions will result in a material reaction that can consist of: warping, expansion, contraction, splitting, checking, discoloration and separation at the joints of cabinetry.

Changes in temperature and humidity that naturally occur from season to season will cause movement in wood products such as hairline cracks and peeling. These types of movement are widely accepted as normal in the cabinet industry and not considered quality defects. Ideally, cabinetry should be kept in a reasonably consistent environment of moderate temperature and humidity. See How Moisture Affects Wood* for more information.

CABINET CARE: Water can wreak havoc on a cabinet's outer shell, destroying the finish and causing structural damage. This is especially true for under sink cabinets where water leaks from the faucet or drain will cause damage. Moisture from ventilation directed on cabinet surfaces or from nearby appliances can result in damage to the finish and lack of ventilation can cause mold and mildew damage. It is important to protect your cabinets from water damage.

Certain household cleaners and other substances can affect the color and integrity of the cabinet finish or appearance over time. See Cabinet Care* for more information.
